Our offerings include weekly tournaments in games such as pool, flag football, air hockey, and volleyball, alongside monthly craft activities and coloring contests. This year, we enhanced our facilities by adding a classic pinball machine and more free craft days for community enjoyment. By providing a consistent and secure space, we foster fulfilling connections among our youth, reminding them of the value of interpersonal relationships. Our existing budget allows us to function for seven months each year. However, the support from generous sponsors like you helps us to provide our services year-round. Many of the young people in our program come from at-risk backgrounds, and our free after-school and summer programs offer vital physical and social activities that they might not otherwise have access to. Our annual fundraising event is instrumental in shaping the future of our community by making a positive difference in the lives of our youth.
