

## ORDINANCE NO. 541

### AN ORDINANCE AMENDING CHAPTER 86, FEES, OF THE BRECKENRIDGE CITY CODE.

THE CITY COUNCIL OF THE CITY OF BRECKENRIDGE DOES ORDAIN:

Amend Chapter 86 to read as follows:

#### CHAPTER 86 FEES

**The following shall be added to Chapter §86-1:**

#### **Chapter 47, Alcoholic Beverages**

§47-4: Temporary License	\$100
§47-10: On-sale	\$2,500
Off-Sale	\$240
Clubs-on-sale	\$500
Seasonal on-sale, golf course only	\$250
§47-16: One-day intoxicating liquor consumption and display permit to any nonprofit organization in conjunction with a social activity	\$100

§126-3: Camping in Welles Memorial Park

§69 - 4.1: Temporary Cannabis Event Registration	\$500

Garbage haulers license	\$300
Nuisance abatement	\$150, plus costs
Mowing grass into street	\$20
