Pursuant to due and proper notice there of a meeting of the Breckenridge Public Utilities Commission was held on Monday, August 4, 2025, at 2:00 p.m. at City Hall – Council Chambers.

Members Present: Commissioners Dennis Larson, Nathan Summerville, Tom Seliski, Hope Karlgaard, and Paul Kaufman.

Absent: Director of Public Services, Neil Crocker and City Administrator Sydney Wiertzema

Others: Finance Officer Liane Mauch

<u>Approval of Agenda</u>. Motion by Commissioner Seliski to approve the agenda as is. Seconded by Commissioner Summerville and carried unanimously.

<u>Approval of Minutes</u>. Commissioner Karlgaard moved to approve the minutes from the July 21, 2025, meeting. Seconded by Commissioner Kaufman and carried unanimously.

<u>Cameral Quotes</u>. Chris Loehr explained that magnets are being tossed in the various substations around the City. This can cause major disruption and damage to services. It would be good idea to install cameras at each substation as well as at the shop where they store much of their materials.

Camera cost: Pack of 4 including NVR - \$599.99 each

Option #1 - Reed River software and them managing the cameras with one NVR: \$399.85 per month with \$400 installation

Option #2 - Red River software with routers at each site and each site would have a NVR with City staff managing cameras: \$298.35 total for the 3 substation sites

Option #3 – Midco software with them managing cameras: \$320.64 per month with \$100 installation

With Option #2, each site would having their own router which they are already set up on with Red River. Up to 20 people are able to have logins to gain access to the cameras. Additional cameras can also be added to the initial 4 if need be. The monthly charge would change a bit with the addition of the shop.

Motion by Commissioner Karlgaard to approve the purchase of the 4 pack of cameras for the 4 sites with Option #2 for the monthly access charge. Seconded by Tom Seliski and carried unanimously.

Overhead Line Training. The City's two apprentice lineman will need to attend overhead school training as part of their Journeyman schooling. The cost for each apprentice to attend the training at MMUA will be approximately \$900 a piece. Motion by Commissioner Kaufman to approve the cost for Easton and Ace to attend the Overhead Lineman training with MMUA. Seconded by Commissioner Summerville and carried unanimously.

MMUA Summer Conference. The annual MMUA summer conference will be held in Rochester this year August 18-20th. Neil did an early registration for two people. Nate would like to attend but no other commissioners were able to. Neil will attend as well. Motion by Commissioner Karlgaard to authorize Neil and Nate to attend the MMUA conference on August 18-20th. Seconded by Commissioner Kaufman and carried unanimously.

There was a question if the commissioners receive any compensation while they are attending the training/conference. They are taking time away from their regular job to attend. Liane mentioned

that she would think they would follow what the City Council members do when they attend a conference. She will look into this .

<u>Disconnect Policy</u>. A first draft of an updated disconnect policy was distributed at the last meeting for any comments/changes. Following a few minor word changes, the final draft was distributed. Motion by Commissioner Karlgaard to approve the updated Disconnect Rule Policy #080425C. Seconded by Commissioner Kaufman and carried unanimously. We will try and get the word out to all of the customers so they are fully aware of any updates to the policy.
